It was suggested that more urgent items e.g. the proposed demolition of Brook House should be dealt with quickly.
9. It was decided that another meeting should be held on the 7 April and Mr and Mrs Cope kindly offered their house as the venue - 53 Park Avenue, Dover.
10. Miss Kennedy offered to design a poster to be displayed in local shops etc.
