THE DOVER SOCIETY

Inaugural Meeting

Menzies Hall, Folkestone Road, Dover at 7.30 p.m.

PRESENT: Chairman- Secretary- and Treasurer-elect, members of the Steering Committee and approx 150 people.

- 1. Welcoming participants, Mr Woolford said that Eurotunnel had already offered membership of its Consultative Committee which he had accepted.
- 2. Proposing the motion that the Dover Society be inaugurated with a Civic Trust constitution, Peter Johnson JP thanked Mr Jack Ind, Headmaster of Dover College, for the accommodation, emphasising the appropriateness to a civic society of inauguration in a college some of whose buildings dated from the eleventh century and in a hall which had housed a pulpit used by John Wesley. Mr Johnson said that the Society arose from growing concern in 1987 of threats to Dover including the District Council's proposed sale of public open spaces. It would not, however, be a mere protest and banner-waving group but would be non-party and constructive, offering inside knowlege. He enumerated some of Dover's unique touristic assets and thought that some, like the Zeebrugge Bell and St James's Cemetery, might be more emphasised. The Channel Tunnel need not be a disaster for Dover which, with better shopping, might rival Canterbury, Bath and York. To general applause he addressed the Chief Reporter of the "Dover Express" saying that he, too, was "backing Dover". The motion was seconded by Ken Wraight and carried unanimously and with acclamation.
- 3. Mr Woolford then outlined the Civic Trust constitution, emphasising its open democratic membership and control with annual election of officers. There would be only one rate of subscription, namely £2.50 per annum, with a reduction to £10 for five-year membership.

- c. David Elms briefly addressed the meeting on the River Dour Association.
- d. At the conclusion of business 73 members joined.
- 8. Mr Woolford listed and illustrated some of Dover's "Assets and Liabilities" with slides loaned by Ray Warner and specially taken by Philomena Kennedy. The following additional suggestions were made from the floor. A second public meeting would follow as soon as there was something to report.
- a. A site on the Western Heights rather than Connaught Park for a caravan park.
 - b. The Barton Path riverside car dump.
 - c. The desirability of listing Brook House.
 - d. Consultation with Dover Harbour Board on the closure of Admiralty Pier.
- e. The rehabilitation of Dover Marine Station as an entry to the town in contrast with mainland counterparts.

- g. The standard of shop facades compared with upper storeys.
