Minutes for 13 October were accepted and passed.

- 1a. PD was producing report on E. Docks visit for newsletter and Volunteer Meeting at Town Hall on 7 November. One new member resulted. More display was suggested for next year with possible sale of cards and badges. There was a demand for newsletter No. 1 and ten more copies would be printed.
- (b) Chairman had produced a 16p. report on 16th annual conference which PK would edit for newsletter.
2. Planning Committee reported on their meeting with David Sturt of DDC and KW said they would probably meet again. PJ suggested that we make an award for the best shop front and PK agreed to publicise in the next news letter. No change was reported concerning the caravan park. Brook House site and the Heritage Centre were discussed. Secretary drew attention here to Minute No. 16 of 11 August. Tesco plan discussed. Chairman presented a considered plan of campaign on which we could base our ideals or tactics. All Committee members received a copy and Chairman requested their own views and comments as soon as possible.
