and was congratulated.

3. Planning sub-committee.

(a) Impact.

The Chairman enumerated the areas and eyesores which had been named in the Press as already under consideration by Impact. Some of these were discussed and commented on.

It was agreed :

- \* That Committee members who have suggestions must send them to KW within one week.
- \* That we should invite suggestions from Society members in the Newsletter and from the general public, as well as from Society members, in the Press.
- \* That members be given a further opportunity to make and to discuss suggestions at the March " Members " meeting, working in small groups.

The Society's recommendations will be collated and forwarded to Impact in tempore opportuno.

We expect to play a leading rôle, with other societies and associations, in the "Forum", but caution was expressed ( JO ) about possible long-term residual responsibilities in the post-Impact period.

(b) The Rolls Memorial

JG has raised the matter with DHB. Decision awaited.

(c) The Minister's reply to our letter about Dover's roads adds nothing to what has appeared in the Press.

(d) KW asked the sub-committee to examine three current planning applications.

(e) Renewed anxiety in the local Press about the future of the War Memorial at Marine Station. We had a previous, unsatisfactory, correspondence with BR about this.

(f) " Maining" of the River Dour. ( Information telephoned by MMcF.)  
DDC had at last taken up with the NRA the possibility of re-designating Dour as a " Main river". This would have advantages and we have pressed for it. It is at present classed as a "Sewer".  
After due consultation and discussion the possibility was ruled out.
