The Secretary summarised the changed situation arising from the withdrawal of Christine Waterman. In keeping with John Peverley's letter of July '92 a draft would be prepared by BA for John Peverley's approval, drawing on the suggestions of ML and PK, and with the agreed extra material.

Christine Waterman has expressed her willingness to act as consultant and to give all possible assistance with illustrations.

The Chairman expressed his thanks to BA for stepping into the breach.

Re-location of the Rolls Memorial

The legal ownership is reasonably secure. ( The monument was donated to D.H.B. and the then Dover Borough Council. ) The D.H.B. presently consider themselves to be the owners and D.D.C. would not disagree.

There remains the cost of removal. Dover Harbour Board estimate £2000-2500. BA will seek two independent estimates and has £750 already promised.

More financial support may be forthcoming from the Royal Aero Club and Rolls Royce, who promise a fly-past and a motorcade for the re-unveiling ceremony.

The Chairman, with Committee acclaim, expressed praise and thanks to BA for his successful perseverance in this matter.
