MINUTES of the 77th meeting of the Executive Committee held at 7.30 p.m.
on Thursday 9 March 1995, at the Royal Cinque Ports Yacht Club.

1. THE MINUTES of the 76th meeting of the Committee of 9 Feb. '95 were passed and signed as correct.

2. MATTERS ARISING

From 9 May 1991 The Peverley Publication

JG outlined the present situation. There was discussion and the Chairman requested to see all draft copy. He would also consult with JP.

Options for future progress could then be considered. No decision was made about who would undertake future work.

Postscript : 11 March. A most helpful letter from John Peverley, one could say a deus ex machina, clears the way.

From 10 Sep. 1992 Re-location of the Rolls Memorial

Publicity : Dover Express Adscene Daily Telegraph : photo and article
Meridian Radio and Dover Express again (Chairman's letter) making sure that BA is given full credit.

JG reported that the move had been approved by the Technical Committee but it would come before the Planning Committee only in mid - April. He will try to short-circuit this, via John Clayton, but it would still be difficult to complete the move in time for the Dover Festival.

Decision : * Re-unveiling ceremony to be postponed to 2 June (the anniversary of the Rolls flight.)

* BA to liaise with Madge re the ceremony

* Ultimately a codicil is desirable concerning ownership :
DHB > DDC > Dover Parish Council, if and when there is one.

From 11 Feb 1993 : Millenium Report.

IG outlined the parturition of the Steering Committee's proposal submission and we await the Ides of March with bated breath.

From 13 Oct. 1994 Laureston Place

JC had not lobbied KCCouncillors and it was decided not to do so for the present. IG is awaiting any result from John Moir's promised démarche to KCC. He might invoke the regulations quoted by MR.

From 10 Nov. 1994 : Communications with FDWS and NRA

JG had not yet had opportunity to contact FDWS.

JC and JO had written to the NRA, within the terms of the Stour/Dour Catchment Management Plan, concerning their responsibilities for the Dour riverside walk, the water discharging into the sea through adits under the rail track at Shakespeare Cliff and reported water extraction by H.M. Borstal.
No full reply has yet been received.

JG had approached the Principal of South Kent College about the Dour riverside walk. Little progress except for a possibility of help with the proposed ramp.

MATTERS ARISING contd.

LW had written to the NRA supporting the opposition to planned merger of the NRA with the Pollution Inspectorate. The letter had been forwarded to the NRA Director dealing with the Environment Bill.
