#### 1) Present:

# 2) Apologies:

Apologies were received from Dr Hale Mr McFarnell. and Capt. Weston;

#### 3) Minutes:

The minutes of the 172nd meeting which had been circulated were agreed.

# 4) Matters arising from the minutes.

Mr Woolford reported on the arrangements made for the Piano Recital to be held on the 17 Jan. and Mr Sutton said that he had been unable to establish the position of the copyright for the Ray Warner films. He said that he would continue his inquiries.

#### 7) The Treasurer:

a) £22 has been collected in subs for this year.

b) £32 paid by the Inland Revenue being interest due because of late repayment under the Gift Aid scheme.

c) £48 received from Advertisers in the Newsletter

d) £650 paid to Adams for the production of Newsletter

e)£31.69 paid for distribution costs.

f) £6 paid for additional Frames under the award scheme and £10 paid to the Clerks to the Justices in support of our application for a drinks licence. (sale of wine at some of our functions)

g) A loss of £9.48 accrued on the November meeting. The bill for the Feast is still to arrive.

h) £110.03 has been added to our CafCash account this being the quarterly interest up to the end of December. Interest rate 3.03%

### 8) Membership Secretary:

Mrs Cope reported that two new members: Mr D.Beecham of Elms Vale and Mr N. Reed of Folkestone had joined the society which brings the total number of members to 441.

# 9) Projects:

Mrs Gordon said that the index of graves in plot 8 of Cowgate is now complete and `consideration was being given to having the plans laminated. There was some discussion on

starting Plot 2. Mr Cope said that the site clearing was continuing and that a strimmer had been donated to the Society by Lt.Col.Bolton needless to say it was gratefully received. Riverwalk "Progress was satisfactory and it was hoped that the survey of the whole river would take place in March.
