

**The Dover Society**  
**Minutes of the Executive Committee, held on Thursday 13 February 2014**  
**at St Paul's Parish room, Dover**

**1. Apologies and welcome**

Apologies from Glyn Hale, Susan Jones and Alan Sencicle. Susan Jones will not be seeking re-election at the next AGM.

Charlene Mineau was welcomed to the meeting. She is currently on a sponsored four-month placement by the Society until June and is being overseen by Mike McFarrell. She is involved in the Dover Film Festival; Town Hall guided tours, the Big Local and River Dour project. She is currently scanning the Eddy Clapson negatives. This will be a long-term project, which could take up to 8 years to complete. Any volunteers are welcome to learn how to scan these negatives, as the skill will be needed by the Society for years to come.

**4. Chairman's Report**

DL and TS attended a Port Community Forum (PCF) meeting. Surprise announcement by the Dover Harbour Board (DHB) about the new vision for the Western Docks. The cargo will be unloaded and distributed at the Western Docks and **may** create 600 extra jobs. This is welcome news and will boost the economy to the town.

There is to be an outdoor gym on the **former** toilet site opposite the Sea Sports centre. AS gave a presentation on SE Railways and **lack of** advanced fares. DHB are supporting this.

JC gave a presentation on Big Local. The Smart project **will** make use of the Clock Tower and old Lifeboat Station for art and photographic exhibitions.

An email was received from Mike Webb about a petition being circulated in the town to ask Dover District Council (DDC) to explain 12 years of inaction and the costs of the DTIZ project at a public meeting. It has **1300** signatures but the petition needs 1600 signatures before DDC has to respond. DL asked **whether** the Society **should** become involved **publicly** and email all our members to make them aware of this petition. A discussion followed and it was agreed the Society should not support the petition publicly. We will inform our members at the next meeting on Monday 17 February and give the Society's view, but stress that individual members are free to sign the petition if they wish to do so.

Graham Wanstal requests help for two projects to mark the 100<sup>th</sup> anniversary of WW1. They are the **repair** of the clock at Pencester Gardens and the bus shelter at Whitfield, located at Tesco's Supermarket. In principle we would support the clock project but need to find out who is responsible for it. It is probably DDC. We also need to know who is responsible for the bus shelter. DL to write to DDC for information on both projects.

Martin Webster **had** emailed DL and TS about possible sites for a new cemetery for Dover. It was discussed about 2 years ago but not heard anything since. A FOI from DDC and a search revealed there is no policy or plans for a new cemetery. DL to write to DDC for information about the present situation and future plans for burials in the town.

The Tallis plaque has been erected at Dover College. A date to mark this may **be during the** week after half term but has not yet been confirmed. When it is the committee members will be informed. Agreed to ask the Head of the college to unveil the plaque.

## 6. Treasurer's Report

The financial report for this month was circulated to members prior to the meeting.

The monies received in January are:

- £48.00 for subscriptions, £28.00 for the current year and £20.00 for the next financial year.
- A donation of £39.90 upon the winding up of the Brighter Dover campaign from the funds left in the account.
- £19.00 from newsletter advertising

The monies paid out are:

- £29.31 for copying
- £11.50 for postage

The Society's January meeting has joined the completed functions list and is in profit of £12.69. The raffle grossed £92.00, after taking out the prize tokens of £30.00, left a net receipt of £62.00.

During the last month the Society was authorised by Dover Big Local to pay out from the money we are holding on their behalf of £320.00. We are now holding £15,122.66 of Big Local funds.

The River Dour Steering Group was awarded a grant of £2,330.00 from Kent County Council. We are now holding funds of £2,745.00 for this group.

As we are approaching the end of the financial year if anyone has any claims for expenses etc. please submit them by our next meeting at the latest with the relevant supporting receipts so they can be paid before the end of the financial year.

As in previous years St. Paul's Church will not give us a definite charge for this room. In lieu of a charge they ask for a donation. Last year we donated £140.00 and I propose we donate the same again this year unless the committee disagrees. Following a short discussion the committee agreed to donate £150.00.

- Cowgate – we are up to date and are hoping to have our work party from East Cliff to Langdon this Saturday.
- Upper Road – following our meeting with KCC Highways MW and I propose using the existing old pathway immediately after the road bridge. It needs steps to make it safe. Highways approached Pathways who have informed us that they intend to deregister, as it is not safe to put in steps. I replied we will oppose on grounds of health and safety. We now need to start campaign, such as with Dover and Thanet Rights of Way and Ramblers.
- Plaque – River Tram Accident of 1917 not had the time yet to research this – ongoing. **TS agreed to supply details of incident.**

We are part of the Catchment Plan with funding for WCCP on preparing plan to meet Environment Agency (EA), environment standards. Aiming at fish passes at Morrisons and Halfords and work at Crabble Corn Mill. Love your river campaign. You decide money to fund equipment for clean up working parties. Working to form local angling, which will also care for river. Work to get river walk sorted
- iv. Street Art – David Little organising and has potential as will involve people of all ages. On 28<sup>th</sup> and 29<sup>th</sup> of June.
- v. Smart Project – Youth engagement
- vi. DADS for DADS. This is to get Dads involved in dancing and expressing themselves.
- vii. Doug and Town TV. Fund to make a video of Dover using students and should be about 10 minutes long.
- Moats Bulwark neglected. Idea to use steps but need EH involvement. They are dangerous and further research needed.
- AS reported on train fares and parking.
- The NHS consultation on outpatients in the form of a booklet was distributed to members of the committee.

#### **10. Town Hall Refurbishment/Guided Tours**

Re the school package - the guides are willing to give it a go. A guide is visiting local primary schools to see if they will support it.

The Town Hall executive committee has sent out letters to consultants inviting proposals for a study on how to sustain the future of the Town Hall and to report back by June.

It has been agreed that BH will take over the winter programme and PHS will continue with the summer programme.
